PARK-OUTS - START

Under the American Recovery and Reinvestment Act, every person who receives unemployment benefits during 2009, is eligible to exclude the first \$2,400 of these benefits when they file their tax returns next year. For a married couple, the exclusion applies to each spouse, separately.

Unemployed workers who expect to receive more than \$2,400 in benefits this year should consider having taxes withheld from their benefit payments in excess of that amount. Those unemployed workers, who have already chosen to have taxes taken out of their benefit payments, should consider the \$2,400 exclusion in determining whether to continue to have taxes withheld.

U.S. Highway 97 to Oregon Highway 31, which goes through Silver Lake and Lakeview before connecting with U.S. Highway 395 to Reno. In the town of Silver Lake, the GPS unit told them to turn right on Forest Service Road 28, and they followed that and some spur roads nearly 35 miles before getting stuck in about 1 1/2 feet of snow.

3. KEY IN PUMP # - 1, 2, 3, 4 (NUMBER IS ON FRONT OF PUMP) 1 & 2 ARE FOR DIESEL FUEL & 3 AND 4 ARE FOR GASOLINE
4. REMOVE FUEL KEY
5. REMOVE FUEL NOZZLE AND TURN PUMP HANDLE TO START PUMP
6. WHEN FINISHED FUELING, TURN OFF PUMP AND RETURN NOZZLE TO HOLDER.
7. PLACE HOSE ON FUEL ISLAND.
8. YOU ARE DONE.
